6. AIMS AND OBJECTIVES OF THE TRUST:

(a) To start nurseries, primary and high schools, colleges, higher education institutions, research center, Orphanages, Nursery Teacher Training and Montessori Teacher Training, T.C.H., Nursing, Training, Computer Training, Cultural training, Skill development courses, and other institutions. Imparting knowledge by helping other charitable & Educational organizations to set up similar institutions for the promotion of education.

(b) To awaken the consciousness of citizens and to create social awareness in relation to public services and utilities and to help in projects that could help the less privileged to attain self-reliance and self-sufficiency either as a coordinating body or otherwise.

(c) To acquire, purchase, take on lease, construct, form, maintain, organize, run, manage, supervise, superintend, co-ordinate, affiliate, control, grant, and otherwise aid study and research center, lecture halls, libraries, schools, colleges, polytechnic, laboratories, museums, clinics, relief centers, nursing homes, maternity homes, exhibition center, practical classes, and other institutions and projects for the betterment of the living conditions of the general public as well as to provide more amenities and facilities to them.

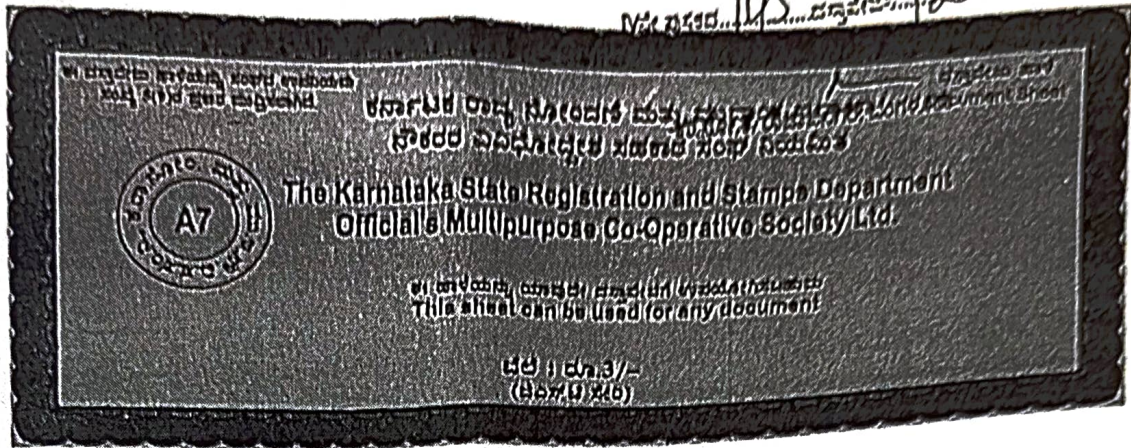

(d) To collect, raise, and receive submissions that on and gifts in Cash or in-kind including from non-residents and others.

(e) To grant/give awards, stipends, scholarship pay, studentship and other allowances, concessions and gratuitous to deserving scholars, students, and other candidates and to grant aid to institutions for the relief of the poor and advancement of education, study, and research for the purpose aforesaid and to grant relief to persons affected by natural calamities like flood, famine, epidemics, earthquake, fire and other calamities of similar nature or of other nature and to give donations to such institutions and persons working for such objects and for relief of the affected persons.

(f) To provide food, clothing, shelter, and medical aid free of cost and/or at nominal or concessional rates to the poor and needy and to give aims to them.

(g) To establish, maintain and run houses and other institutions for maintaining, training, educating, and protecting widows, orphans, destitute, displaced persons, and other needy persons and to give donations and/or other aids to other institutions and persons doing welfare services as well as encourage and help financially or otherwise underprivileged ladies to become self-sufficient or help in their marriage, etc.

(h) To encourage, help, establish, and maintain facilities for the promotion of public sports and physical sports and physical culture and to establish, maintain, and grant aid to centers for study, research, and diffusion of Indian Art, Philosophy, and Culture.
