Subject: Regarding issuance of completion certificate of M/s. Amruthaya Central School situated at No.58/3, Kattigenahalli, Jala Hobli, Bangalore North.

An advisory letter has been issued by the Fire and Emergency Services Department on 24-01-2025 as per your request for the M/s. Amrutaya Central School educational building constructed at Kattiginahalli No.58/3, Jala Hobli, Bangalore North, with a ground floor height of 20.00 meters and 04 upper floors.

In your letter of reference (2), you have requested that the installation of fire extinguishing equipment in the said educational building has been completed and that a completion certificate be issued by the Fire and Emergency Services Department.

As per your request, the District Fire Officer, Peenya Fire Station, Karnataka Fire and Emergency Services inspected the educational building constructed at No. 58/3, Kattiginehalli, Jala Hobli, Bangalore North on 05-02-2025 and stated that as per the advisory letter issued by the Fire and Emergency Services Department, fire protection and control, installation of fire extinguishing equipment and safety measures have been fully implemented in the educational building and that only fire training is pending for the employees/staff in the said building and after the completion letter of the said building, it will be possible to arrange fire training for the staff in it.

Therefore, the building constructed at M/s. Amrutaya Central School, Kattigenahalli No.58/3, Jala Hobli, Bangalore North, with a ground floor height of 20.00 meters and 04 upper floors, the Educational Building Fire and Emergency Services Department Advisory Letter No. GBC (2) 3425/2024, dt: 24-01-2025, Fire extinguishing equipment and safety measures shall be strictly followed and as agreed in your letter of undertaking dated 25-02-2025, fire extinguishing equipment shall be kept in good condition and arrangements shall be made for 40% of the staff/employees in the building to undergo appropriate training on fire protection and control measures at R.A. Mundur Fire and Emergency Services Academy, Bangalore within 03 months.

This Completion Certificate shall be valid for the next two years from the date of issue. It has been further advised to renew this completion certificate.

It has also been advised that if at any time the fire protection and fire extinguishing equipment installed as per the department's recommendation is found to be not in good condition or the safety measures are not strictly followed or any additional structures are constructed in the open area left by law around the said building or any kind of permanent/temporary obstruction is caused, this 'completion' certificate will be void and further action will be taken within the framework of the law.


