(k) To help, contribute, promote, take, and amalgamate wholly or in part with any other society, trust, body, or institution whether registered/incorporated or not, having public charitable objects similar to those of the Trust.

(l) To purchase, take on lease or otherwise any establishment, land, building, easement, or other interested in trust estate and all kind or personal properties required for Trust and sell, let on lease, mortgage, or otherwise dispose of or grant rights over any of its properties or other properties or any portion thereof whatsoever belonging to the Trust.

(m) To borrow or raise money or sums of money with or without security and on such terms as may be through fit by the Trustees.

(n) To do all other acts, deeds, matters, and things as are incidental or conducive to the attainment of the objects of the Trust or any of them.

MANAGEMENT OF THE TRUST:

8. The general management and control of the Trust for the purpose of managing the Trust affairs and the Trust properties and carrying out the objects of the Trust aforesaid shall be vested in the Trustees and with the generality of the objects and powers abovementioned they shall have the power to do all or any of the followingacts, deeds and things that is to say:

(i). To enter into contracts and borrow money for the purpose of the Trust and Management of its properties and assets.

(ii). To appoint officers and servants at such remuneration (if any) as they think fit.

(iii). To convert and get in the Trust property and/or to vary the investments for the time being.

(iv). To open an account with any bank or banks, to operate such acquaints and to give instructions to the Bank and to provide for opening and operating accounts by one or more of the Trustees or by one or more agents appointed by the Trustees.



(v). To adjust, settle, compromise, compound, and transfer to arbitration, all actions, suits, and claims, deemed Trustees or by one or more agents appointed by the Trustees.

(vi). To adjust, settle, compromise, compound and refer to arbitration all actions, suits, claims, demands, and proceedings regarding the Trust Properties and assets.

(vii). To appoint, constitute attorney or attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested in them under these presents, from time to time, revoke such attorneys and agents and to appoint other or others in his or her or their places.

(viii). To appoint or make provision for the appointment of any person (including all or any of the Trustees) as Committee or Administrator or Managing Trustee or otherwise for the purpose of the administration of the Trust in such manner and subject to such rules and regulations as the Trustees may prescribe and also to appoint or provide for the appointment of separate trustees to hold any property or any fund or investment subject to such rules and regulations as the Trustees may from time to time think fit.

(ix). To set apart the whole or part of the income or the corpus or part thereof or any of the objects of the Trust.

9. (i). The Trustees shall be chargeable only for such sums of money, stocks, shares, and funds as shall actually come into their hands and shall not be answerable or accountable for neglect, default, acts of omission, or commission of other Trustees nor of any bankers or otherpersons with whom the Trust properties or any securities may have been deposited or handed over unless caused by their neglect or default.

(ii). The receipt of a person authorized by the Trustees or a resolution of the Board of Trustees for any money paid or any property transferred or delivered to the Trustees in the execution of any of the Trusts or powers hereof or for the purchase sums of money or any property authorized to be sold shall effectually discharge person or persons so paying, transferring or delivering.

10. The Trustees will not be entitled to receive any remuneration as Trustees but may reimburse themselves for all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

11. The Trustees may from time to time frame rules for the conduct of the affairs of the Trust and regulate the meeting of Trustees. In the absence of such regulations, all matters will be decided by majority.

12. The funds and the income of the Trust shall be solely utilized for the achievement of its objectives and no portion of it shall be utilized for payment to the trustee's members by way of profit, interest, dividends, etc.

13. If any Trustee dies, retires, or becomes unfit or incapable to act, the continuing or surviving Trustees or Trustee will be competent to appoint Trustee in place of such Trustee so dying, retiring, or becoming unfit or incapable to act.

14. Upon appointment of any new Trustee or Trustee the fund and the Trust property shall stand transferred to and become vested in the new Trustee or Trustees jointly with the surviving or continuing Trustee or Trustees.



15. The Trustees shall cause true and accurate and regular accounts to be maintained of all money received and spent and of all matters in respect thereof in the course of management of Trust properties in relation to the carrying out the objects and purposes of the Trust as well as of all the assets, credits and effects of the Trust.

ACCOUNTS CLAUSE:

16. The Trustees shall cause the true and correct account to be kept of the sums of amounts of money received and expended on behalf of the Trust. The Annual Account shall be closed on 31st March of every year. The accounts of the Trust shall be examined and the correctness of the accounts and the Balance Sheet as certified by a Chartered Accountant appointed by the trustees and the Audited accounts shall be placed before the meeting of Trustees conveyed for this purpose for adoption.

IRREVOCABILITY CLAUSE:

17. The Trust hereby created is not revocable at the instance of the Authors of the Trust at any time and under any circumstances.

DISSOLUTION CLAUSE:

18. In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees or members of the Managing Committee or Government body, but the same shall be transferred to another charitable trust whose objects are similar to those of this trust and which enjoys recognition U/s 80G of the Income Tax Act, 1961, as amended from time to time.



AMENDMENT CLAUSE:

19. No amendments to the Trust deed shall be made which may prove to be repugnant to the provisions of Sections 2(15), 11, 12, and 80G of the Income Tax Act, 1961, as amended from time to time. FURTHER, NO AMENDMENT SHALL BE CARRIED OUT WITHOUT THE PRIOR APPROVAL OF THE COMMISSIONER OF INCOME TAX.

20. The Trustees may from time to time appoint sub-committees consisting of such persons as they may deem fit as and when necessary and assign to them such duties and delegate to them such powers as the Trustees may deem proper. Each of the sub-committees shall be responsible to work under the general control and direction of the Trustees and shall be guided by the Rules, regulations, and Byelaws generally applicable to the sub-committees as may be specified by the Trustees. Such sub-committees shall function for such time unless dissolved earlier as the Trustees may decide. The Trustees may nominate any of themselves to be ex-officio members of all sub-committees.

21. The Minutes of the proceedings of every meeting of the Board will be entered in a Minute Book to be kept for that purpose and signed by the Chairman of such meeting or of the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business transacted at such meeting.
